THE WAREHOUSE ASSESSMENT PAGES 1-27

(6-8 hours to complete)

- Is an assessment for warehousing operations
- Provides a walkthrough of warehouse/logistics operations

THE BUSINESS ASSESSMENT PAGES 27-32

(4 hours to complete)

- Is an assessment for business and financial operations
- Provides assessment space for business operations, such as P&L reviews, marketing, sales strategy, etc.

Self-assessment provides *ownership, cost-effective insight, and great value* to firms that choose to adopt the tools. Compared to the cost of a consultant- which can range from \$50K-\$250K depending on the business size- the value is incredible.

- Revisiting the foundations of your operations, business model and profitability establishes strengths and vulnerabilities
- Benchmarks are the tools for building sustainable growth despite the shifting tides in the marketplace

WHO SHOULD USE THESE TOOLS?

Supply chain managers are often the key point in any firm with insight into both operations and strategy. These are the ideal individual to complete both portions of the assessment. In the absence of a SC manager, it is recommended that a mid-level manager in a position to unbiasedly read and evaluate each element of the firm complete the assessment.

It is vital that executive management ensure that the evaluator completes the self-assessment without bias. Ensuring that the tool is designed for process and business improvement rather than employee evaluation is critical!
